From the first day of your Eliassen Group contract, you have 30 days to elect dental coverage, healthcare benefits and/or Medical, Dependent Care or Commuter Flexible Spending Accounts. After 30 days, you are not eligible to enroll in these benefits until open enrollment for the following plan year unless you have a qualifying event. All benefits will be effective the first of the month following the hire date.

Flexible Spending Accounts

Medical Flexible Spending Account:

Tax-free reimbursement for your out of pocket medical expenses up to \$2,000.00 per calendar year.

Dependent Care Flexible Spending Account:

Tax-free reimbursement for your work-related dependent care expenses up to \$5,000.00 per year.

Commuter Flexible Spending Account:

Tax-free reimbursement for your commuting expenses. Choose to either reimburse for Parking, Mass Transportation or both. Up to \$230 a month for parking and Mass Transportation.

For more information on the Flexible Spending Programs you can visit or email the HR department. Please make sure you estimate the correct amount taken out each week, if you do not reimburse for the money, you will lose it. All claims for money need to be made before February 28 of the following year or within 60 days of separation from Eliassen Group.
